It is not believed the information available regarding CARBO justifies additional investigation regarding him at this time. CARBO undoubtedly lost his nerve after capture in the Cuban invasion and made whatever statement he could to protect himself. He is not presently active in Miami, but in the event pertinent information is subsequently developed regarding him, this case will be reopened.

It is noted MM 492-S, who is well acquainted with CARBO, has advised that based on his knowledge of the situation, he does not believe CARBO to be a communist or sympathetic to the CASTRO regime.
