ARAGON advised that Dr. MIRO CARDONA has a CIA contact in Miami, Fla., and the CIA contact, whose identity is known to the NYO, has been in direct contact with subject's group. In discussing the Subject's group with his CIA contact, MIRO CARDONA learned, according to ARAGON, that CIA does not like this group but believes that it could be used at times for certain specific jobs.
MIRO CARDONA, therefore, concluded that although the Second Front Escambray is not being directed by CIA, they are called upon at times to do some particular mission for them.
