Re Miami reports of SA WILLIAM MAYO DREW, JR. dated 4/12 and 5/31/62; Newark report of SA MAURICE T. BOWMAN dated 12/29/61; and New York letter to Bureau 6/4/62.

Referenced Newark report set forth information concerning a past successful fund-raising effort by MENOYO in Union City, N.J., and the surrounding area during September, 1961, with the assistance of members of the Liceo Cubano Jose Marti, a Cuban social club in Union City.

On 5/22/62, PSI DIONISIO FELINO RODRIGUEZ, Union City, N.J., advised SA MAURICE T. BOWMAN that he knew of no organized group or member in the Second National Front of Escambray existing in Union City or Newark, N.J. No large collections such as that made in September, 1961, were known to have recently taken place in New Jersey. Past members of the Liceo Cubano, who participated in the prior fund drive, were described as belonging to various other anti-CASTRO groups but to have been willing to cooperate with MENOYO because of their faith in his alleged plans to sponsor guerrilla activity in Cuba. PSI advised, however, that there was one individual by the name of SILBERIO RODRIGUEZ, whose employment and address were unknown, who was said to have occasionally solicited money at Union City for MENOYO under the name of Dr. ARMANDO FLEITES. The last solicitation of this type was said to have been around March, 1962. No receipts would be issued by RODRIGUEZ, who indicated to the contributors that their names were being made a matter of record. Source knew of no other individuals soliciting funds in New Jersey for MENOYO, FLEITES or their group.
