WALLACE SHANLEY, Asst. Agent in Charge (Enforcement), U.S. Customs, Miami, on 9/25/63 advised that Customs had no additional information re this plan and was not investigating the allegation in view of the lack of any specifics upon which to base an investigation.

In view of previously received info that ELOY GUTIERREZ MENOYO was of interest to and a source of U.S. Army Intelligence, contact was made with the office of their covert representative in Miami who advised that Army Intelligence no longer maintained a relationship with GUTIERREZ (MENOYO. They had no info re this matter Army Intelligence is MM T-2 and Major VALLESI, Aide to Major JUNIUS WATLINGTON, furnished the info. (X (4)

ROBERT KING FAA, Miami, contacted 9/24/63, advised that in view of the non-specific nature of the CIA Information Report, it did not appear that it could be tied in with any other data. He pointed out that without an "N" number, or type and make of aircraft, it would not be possible to identify this information with a specific aircraft.
