CIA, Miami advise they have no operational interest in either MENOYO or GERALD PATRICK HEMMING, do not anticipate any in the future, and have doubts concerning their motives and reliability.

The U.S. Coast Guard is presently in the process of checking its records to ascertain the identities of any boats stopped by them between August 16th and August 17, 1961.
