Re Havana letter to Bureau September 19, 1958. (u)

Lt. ROBERTO VILA, investigating agent for the Cuban Army Intelligence Service (SIM), has furnished a photograph of fingerprints taken from a body believed to be that of the captioned subject who is alleged to have been killed by Cuban Army forces in Victoria de las Tunas, Cuba, September 16, 1958. (X)(u)

It is requested that these prints be searched through Bureau records to verify whether they are actually prints of the subject. It is noted that sources have furnished unconfirmed information that subject is an American citizen and veteran of the U. S. Army, World War II. (X)(u)

Interested offices in the U. S. Embassy, Havana including the Ambassador and CIA, have asked that they be notified immediately as to the results of our search of these fingerprints. It is requested, therefore, that this matter be handled expeditiously and that results of the search be sent to this office by cable. (X)(u)

Two extra copies of this letter are submitted to the Bureau for forwarding to the Miami and Cleveland Offices for information. (u)

The enclosed set of fingerprints may be retained in Bureau files. (X)(u)
