Re Cleveland letter to Director 4/30/59.

PCI DONALD GEORGE ABAJAY, Toledo, Ohio, on May 25, 1959, advised SA ROBERT H. BRADNER that he had associated closely with WILLIAM ALEXANDER MORGAN for about four years and that during that time MORGAN never mentioned the Communist Party (CP) nor indicated any interest in communism whatsoever. ABAJAY thought that MORGAN, due to his nature, would have made it known if he had had any interest in, or association with, the CP. Source did advise, however, that though he may have had no past contact with the CP, MORGAN is an opportunist and would probably undertake any operation which might prove profitable to him.

ABAJAY stated that, to the best of his knowledge, MORGAN had not been within the continental U. S. since he joined the CASTRO forces in Cuba.
