Reference is made to my communication  
dated August 3, 1959. (u)

A source with whom insufficient contact  
has been had to determine his reliability and who  
is described as a counterrevolutionary advised in  
early August, 1959, that he was in Miami, Florida,  
on July 30, 1959, and saw the Dominican Consul there  
give Morgan \$200,000. Reportedly, one Dominick,  
allegedly a member of the "Mafia," was also present.  
Dominick may be identical with Dominick Bartone, who  
is presently under indictment in Miami in connection  
with the attempted smuggling of arms destined to the  
Dominican Republic. (S)(u)

The source stated that Morgan was believed  
to be traveling between Cuba and the United States  
by private boat. (S)(u)
