Reurlet 8/19/59 captioned "Anti-Fidel Castro Activities, Internal Security - Cuba" your file 105-1742. Attention is directed to page 15, paragraph 3, of the letterhead memorandum enclosed with relet which sets forth information attributed to T-2 (Alicides de los Reyes). T-2 reported Augusto Ferrando, Dominican Consul General in Miami, had stated that Trujillo is extremely angry and upset over trickery of William Alexander Morgan, and it was his opinion that Trujillo would take steps in the future to eradicate Morgan.

It is not clear from above-cited statement whose opinion it was that Trujillo would take steps to eradicate Morgan. By return mail, furnish complete details as to alleged statements of Ferrando, specifying whether Ferrando or T-2 offered opinion as to Trujillo's possible action against Morgan.

In view of recent assignment offered to Lieutenant Rene Batole by subjects to locate Morgan and determine his present status, possibility should be borne in mind that Dominicans are attempting to locate Morgan in order to seek revenge against him for his betrayal of the anti-Castro group. You should, therefore, maintain close contact with T-2 for any additional information along this line he may be able to elicit. You should also be most alert for information bearing on this matter which may be available to other sources of your office. Keep Bureau promptly advised of any developments in this connection.
