She noted that she recently received another letter from subject in which subject once again related that she wishes to leave Cuba, however, noted she would not leave Cuba without her two children. In her letter subject advised that her husband, RENE VALLEJO, is presently Chief of Staff of a hospital, however, has lost his confidence in the Castro Government, and there are indications that he is not presently trusted by the Castro Regime. Subject also mentioned that her son, RENE, is away at some sort of a training camp and that he visits his mother and sometimes his father usually on each Friday, and that during the remaining time he is away at this camp.

CUBA
Mrs. FEDYNSKY noted that subject's son, RENE VALLEJO was born April, 1948, and that her daughter, CARMEN ALEXANDRA, was born October, 1952.

The Cleveland letter to Bureau and Cleveland letterhead memorandum both dated April 17, 1962, are being furnished the New York Office to provide background information concerning this matter.

In addition, it is pointed out to the New York Office that CSWF 1259-S on March 9, 1961, advised SAs JOSEPH E. MICHALSKI and CHESTER J. GUSTOWSKI that he recalled that a MARIA DZIEDZUSZYNSKA had been an agent of Section II (Operations Directed Against the United States and Other Western Countries), Department 1, (Foreign Intelligence), Polish Security, (UB), prior to her departure, possibly for South America, a few years ago. Source stated that she was in her 40s and that she had a sister who was also utilized by the UB in Poland. ~~(u)~~

Source further stated that he had no further information about her, but that it was entirely possible that she was presently in Cuba.
