MARIO REYNALDO MARTINEZ, PSI, MIAMI. PSI, RADIO TECHNICIAN, WHO HAS FURNISHED RELIABLE INFORMATION IN PAST, FURNISHED FOLLOWING ON JULY TWENTYEIGHT TO SA LEMAN L. STAFFORD, JR. COLON JOSE MANUEL CARAMÉ, WHO WAS CHIEF OF POLICE IN HAVANA DURING REGIMES OF CUBAN PRESIDENTS RAMON GRAU SAN MARTIN AND CARLOS PRIO SOCARRAS, NOW RESIDING IN MIAMI, CONTACTED PSI JULY TWENTYFIVE. CARAMÉ INDICATED HE IS NOW CONNECTED WITH FRENTE REVOLUCIONARIO DEMOCRATICO PAREN REVOLUTIONARY DEMOCRATIC FRONT, FRD ENPAREN AN ANTI CASTRO ORGANIZATION COMPOSED OF FIVE DISTINCTIVE GROUPS, ONE OF WHICH IS HEADED BY MANUEL ANTONIO DE VARONA. CARAMÉ INDICATED THAT THE FRD COULD POSSIBLY USE PSI IN CONNECTION WITH INSTALLATION OF RADIO EQUIPMENT FOR BROADCAST OF ANTI CASTRO PROPAGANDA. ON JULY TWENTYEIGHT, PSI WENT TO MIAMI HEADQUARTERS OF FRD AND MET MANUEL RIVEROHSETIEN, CUBAN, WHO TALKED OF FRD GETTING VESSEL ON WHICH WOULD BE PLACED BROADCAST TRANSMITTER FOR PROPAGANDA PURPOSES. PSI TOOK RIVERO TO SEE A BROADCAST TRANSMITTER AND POWER PLANT AVAILABLE FOR SALE WHICH COULD BE PLACED ON BOARD A VESSEL, AND RIVERO INDICATED EXTREME INTEREST IN PURCHASING THIS EQUIPMENT AND HAVING PSI INSTALL SAME.
