On 5-23-61 Bureau liaison obtained information from CIA classified "Secret" from a defector whose identity has not yet been disclosed (CSWF 1259-S) that subject, born 2-19-31, in France and married to Bill Rune Bengt Hagberg, presently serving as Swedish consul in Havana, Cuba, was recruited in Europe in 1950 by KGB. CIA advised subject's husband has been stationed at Havana since 3-60 and that subject traveled to Miami on or about 1-16-61, stopping at the Columbia Hotel and returned to Havana 1-19-61. No additional information is currently available to Bureau, but CIA is preparing a report in this matter. Bufiles contain no info identifiable with either subject or her husband. (S)(U)

WFO should review files of State Department and records of Central Office, INS, re subject and determine info re possible previous travel to US by subject. Bureau liaison is attempting to ascertain from State most effective means of placing stop to insure that we are notified in event of future travel to US by subject. (S)(U)

MM should conduct discreet inquiry through established sources only at Columbia Hotel, MM, in effort to determine subject's activities and contacts during her reported three-day visit to Miami. (S)(U)

This matter must be handled in a most discreet manner so as not to jeopardize either security of informant or prematurely alert subject you are interested in her activity. Submit results in form suitable for dissemination. You will be furnished results of additional pertinent info from CIA. (S)(U)
