show that Pedro Luis Gutierrez sought asylum in the Dominican Republic during 1933, returned to Cuba in 1936, and again took asylum in the Dominican Republic in September, 1944. It is known that he later returned to Cuba but our files do not indicate when.

One of our sources who formerly worked closely with Pedro Luis Gutierrez has received information indicating that as of May, 1963, Gutierrez was a lieutenant in the Department of Information of the Cuban G-2 and that his wife was at that time a member of the Cuban Militia.

In view of the foregoing, it is suggested that [Pedro Luis Gutierrez might possibly be identical with "Alberto."] ~~(S)~~(u)

NOTE: Classified "Secret" since information from a previous CIA letter so classified is repeated herein and since we refer to specific activities in a foreign country of one of our representatives. CIA has brought a defected Cuban official from Brazil to the U. S. and he has been attempting to give CIA the exact picture of the Cuban intelligence organization as it exists under Castro. He described "Alberto" as a key intelligence official and said employees under "Alberto" did not know his true name but knew him as the person who claimed to have been responsible for the arrest of a German master spy in Havana during 1942. ~~(S)~~(u)

Section Chief D. J. Brennan recalled Luning's identity and review of his file shows that SA Edwin L. Sweet of Miami Office and MM 492-S, who was then a high Cuban Police official, were responsible for Luning's arrest and they also obtained a full confession from Luning. Checks with SA Sweet and MM 492-S show Gutierrez was present at the arrest and MM 492-S, who served as Gutierrez's superior for many years, now believes Gutierrez was a fanatical communist throughout their association.
