of State, Havana, Cuba, from May 1, 1960, to April 17, 1961.

MM T-1 is MM 853-S, a paid source. He furnished information which was set forth in Miami memorandum 12-14-61 and CIA has advised that it would appreciate receipt of his identity and present whereabouts. It is noted that if it is determined that he may possibly possess information of interest to CIA, interview with him might be requested. It is felt we should not reveal his identity to CIA since he is an active source; however, if CIA desires information we could check with source to see if he has any information of interest to CIA.
