ReBuairtel 10/9/63.

On 10/10/63 Central Intelligence Agency (CIA) advised by liaison that it had decided not to interview Pelleya prior to his departure for Brazil. CIA is alerting its Rio Office concerning the trip and, after Bureau disseminates data developed by Pelleya on the trip, it will consider desirability of interviewing him.

Rio should expedite submission of instructions concerning contact of Pelleya by Legat, Rio, as requested in Buairtel 10/4/63. Final briefing of Pelleya should be held in abeyance until after receipt of desired material from Rio, but Miami should take care of other necessary details in the interim.
