Subject is in the process of making plans to travel to Brazil where he will meet with Raul Roa, Jr., Cuban Ambassador to Brazil. Pursuant to instructions, the Liaison Agent advised CIA that we would permit the Agency to brief Pelleya before he departed bearing in mind that CIA might be in a position to alert the source concerning matters of interest to CIA. (S)

On 10/10/63, Will Kerbe, CIA, advised the Liaison Agent that after analyzing the situation, CIA has decided not to interview Pelleya prior to his departure. CIA is alerting its office in Rio de Janeiro concerning Pelleya's travel. We already have an agreement with CIA that the Agency will not have any access to the source while he is in Brazil. Kerbe advised that after the Bureau disseminates its results of the debriefing of Pelleya upon his return, CIA will then give consideration to interviewing the source. (S)
