On 11/14/62 EDUARDO RAMOS, M.D., St. James Hospital, Newark, N. J., (protect by request) a Cuban refugee doctor of medicine, the reliability of whose information has not been established, advised as follows:

During the week in October, 1962 when President KENNEDY announced the quarantine of Cuba, he, RAMOS, was told by RAUL TORRES who is in charge of the office of the Revolutionary Council in New York City, that all anti-CASTRO groups have now been given "the green light" by CIA. Further, all groups, as long as they accept the direction and guidance of CIA, will be free to recruit and train for an eventual expedition to Cuba. (S)(u)

Dr. RAMOS advised that he understood that this was an unofficial agreement with the anti-CASTRO groups. Dr. RAMOS explained that by this he meant that the agreement was an oral one and could not have official sanction. He could furnish no further details.

Since the current relationship between CIA and the anti-CASTRO groups is not known at Newark, it is being left to the discretion and the office of origin whether TORRES or CIA through liaison should be contacted regarding the above information. (S)(u)

No letterhead memo is being submitted as the above information concerns administrative policies of CIA and perhaps other highly placed individuals in the government. (S)(u)
