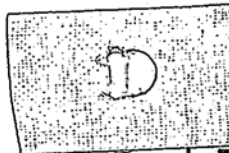
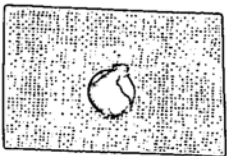

The above-captioned individual is a former Cuban labor leader who is presently residing in Washington, D.C., and who has been in contact with this Bureau. He was formerly head of the Federation of Cuban Workers and has been active in labor circles in Cuba and in Latin America. He has furnished this Bureau information concerning Cuban activities and claims to have a network of sources in Latin America that could be of assistance to this country in its fight against communism. (A)(U)

Mujal has claimed he had previous contact with representatives of your Agency in Cuba and revealed that he has been in contact in the past with Jay Lovestone whose background is known to you. In addition, Mujal has expressed a desire to contact your Agency and has claimed to have made several attempts to communicate with individuals he believes to be connected with your Agency. (A)(U)

It is requested that you furnish this Bureau any pertinent data in your possession concerning Mujal. It is also requested that you advise whether you have any interest in contacting Mujal.

An expeditious reply in this matter would be appreciated.
