Enclosed hereto for the Bureau are the below listed items, all of which are written in the Spanish language, which were furnished by MUJAL to SAs RICHARD B. KELLOGG and HOWARD P. WINTER on 4/28/60: Three 6" X 8" books, two of which are cardboard covered, divided with alphabetical dividers, and marked "A L" and "M Z", and the third of which is merely bound with an Acco fastener, and divided with five labeled tabs. MUJAL said the persons and organizations mentioned therein are Communists, and that information has been gathered at his instructions by "his men" in Cuba since the rise of FIDEL CASTRO. It was brought out of Cuba to him by "his friends," who have since returned to Cuba. A list of names on a single sheet of paper ón the letterhead of Ministerio del Trabajo, Republica de Cuba, some of which are checked/in red pencil. (0 1. MUJAL said those that are checked are individuals publicly known in Cuba as communists. Stapled to that sheet is a list of names captioned, "COMUNISTAS EN LOS LABORATORIOS TIMOUTI TOUZET."

- 3. One 11-page document captioned, "FEDERACION GASTRONOMICA," which identifies and furnishes biographical data concerning various persons commented on therein.
- 4. One $3\frac{1}{2}$ -page document captioned, "FEDERACION TABACALERA NACIONAL," which lists the officers of that union and furnishes biographical data on those who are known to be communists, and who are listed in red. ((ω)
- 5. A compilation of papers bound with string identifying various individuals and furnishing data and newspaper clippings, et cetera regarding those individuals. One page thereof is captioned, "RELACION DE LOS PRESIDENTES O ENCARGADOS DE LOS COMITES NACIONALES DEL CONCURSO PRO-FESTIVAL DE LA JUVENTUD Y SUS DIRECCIONES POSTALES."

MUJAL advised that particular information on that page was stolen from the files of the headquarters of the Communist Party located on Carlos Tercero Street, Havana, Cuba.

6. One Manila folder entitled, "PROPAGANDAS Y VOLANTES DEL P.S.P.," containing various examples of propaganda issued in Cuba.

MUJAL specifically requested that copies of this material be made available to CIA. He said it is not necessary that the originals be returned to him.

It is requested that the Bureau translate this material, furnishing a copy of same to WFO. It is further requested that a copy of the translation and or the original be made for submission to CIA. In that regard it is noted MUJAL does not desire that the originals be returned to him so the Bureau might consider forwarding the originals to CIA, after translation is obtained. In the event it is felt that dissemination of the information should be made to agencies other than CIA, it is requested that, if possible, sufficient copies of the translation be made to afford such dissemination.
