Reference is made to memorandum dated 5-6-60 from Mr. Donahoe to Mr. Belmont. The subject, a well known labor personality under the Batista Government in Cuba, volunteered information to the Bureau concerning alleged communist activity in Cuba. [By letter dated 5-9-60 we informed CIA that Mujal allegedly had a network of agents in Latin America and that he was interested in contacting CIA. We asked CIA to advise us if the Agency was interested in the subject.] *(u)*

On 5-17-60 Mrs. Jane Roman, CIA, advised that Mujal was well known to CIA but he was not regarded as an individual who could furnish any information not already known to the Agency. CIA does not desire to establish contact with him. The Agency is under the impression that Mujal is seeking financial support. *(u)*
