NOTE:

Pino is Alternate Cuban Delegate to OAS who has kidnaped one Cuban Embassy employee, beaten another, and threatened others. State has been considering persona non grata action against him but was reluctant to take any action prior to the break in diplomatic relations on 1/3/61. His status as a representative of an international organization apparently has also hampered action by State. Dr. Manuel Mencia, former First Secretary at Cuban Embassy, was told by another former employee at the Embassy that Pino had threatened life of Nicolas Rivero, leader of anti-Castro group, or someone connected with Rivero. WFO indicated clearance for interview should be obtained from CIA, which supports the anti-Castro group, but no such clearance is needed. (JFK)
