Information pertaining to the description of the International Coffee Agreement was obtained by SA JOSEPH E. SCULLY through a phone call to the International Coffee Agreement. It is noted that it was not necessary for SA SCULLY to identify himself.

The enclosed letterhead memo is classified "Secret" due to the sensitive nature of the source. In the event this information is downgraded, it should receive a classification of "Confidential" inasmuch as it reveals our investigative interest in a representative of a foreign diplomatic establishment. The information also could possibly result in identification of a confidential informant of continuing value and compromise future effectiveness thereof.
