The New York Office is requested to check their indices for any information identifiable with Roque and advise Newark and WFO of the results of the above check.

For the information of the Newark Office, it is noted that Roque placed a long distance call to one Mrs. Roque, possibly his wife, at Hoboken, New Jersey, telephone number OL 9-9218. The Newark Office is requested to check indices and conduct the investigation necessary to identify Roque. Newark is requested to advise WFO of the results of their indices check and investigation.

The enclosed letterhead memo is classified "Confidential" inasmuch as the information reported, reflects our investigative interest in a diplomatic official of a foreign power and because the information reported could reasonably result in identification of confidential informants of continuing value and compromise their future effectiveness.
