On 12/6/61, SA EDWIN D. KUYKENDALL received an oral report from [DL-1-S] (f)(u). This report was dictated 12/6/61 to Jewell Gilstrap and was transcribed 12/8/61. Report was authenticated by informant 12/11/61 in the presence of SA EDWIN D. KUYKENDALL. Report has been dated 12/6/61 and serialized as [134-2A-416.] (f)(u)

That report revealed that on December 6, 1961, AUGUSTIN ESTRADA, from about 10:00 A.M. to 10:20 A.M., visited DAN YARBOROUGH at 1701 Bourbon Street, Dallas. ESTRADA said he is waiting for notification of the arrival of "the lady." ESTRADA said he expected 25 to 30 people in the get together with "the lady." (f)(u)

ESTRADA said he, DAN YARBOROUGH and ANDY _____, the barber, at Harwood and McKinney, Texas, were to have a conversation on Friday night, December 8, 1961. (f)(u)

ESTRADA said that he wanted to "keep up things" and asked if YARBOROUGH had an old "Worker." YARBOROUGH said he did and obtained it. ESTRADA told YARBOROUGH he is a "lifesaver" by having the old "Worker." ESTRADA said he wanted to subscribe to it but knew that whoever subscribed would be checked on and that it probably would be stopped. YARBOROUGH agreed to let the "Worker" come to him and Estrada appeared pleased. Estrada borrowed an envelope from YARBOROUGH and wrote YARBOROUGH's name and address thereon and addressed the envelope to the "Worker," obtaining the address from the old issue of that publication. (f)(u)

YARBOROUGH told ESTRADA that he always "depends upon him," ESTRADA, for advice. At about that time one of YARBOROUGH's personal friends, ROY EVANS, employee of the Dallas City Public Works Department, entered YARBOROUGH's building and AUGUSTIN ESTRADA departed. (f)(u)

Informant had no additional information.
