EMPHASIS AT THE FIRST SESSION WAS SAID TO BE TO STUDY THE PRODUCTION OF PLAYS AND SHORT STORIES WHICH WILL SHOW THE CONDITION OF THE AMERICAN NEGRO AND TO WRITE PLAYS SUITABLE FOR NEGRO GROUPS TO PUT ON TO STIMULATE THE NEGRO RACE TO TAKE STEPS FOR ITS OWN LIBERATION.
