SYNOPSIS OF FACTS:

LAWSON reported to have recruited his wife SUE into the Communist Party (CP) in 1936. Also recruited T-5 into the CP in 1938. On 3/14/56 ALBERT GLASSER, musician and composer, and his wife KATHERINE recalled LAWSON as an important figure in the CP in 1943 when the GLASSERS were members. [LAWSON recently expressed himself as feeling that the actions of the USSR in all cases cannot be completely defended.] During 1955 LAWSON has been reported connected with a number of Communist-dominated organizations, including California Emergency Defense Committee, American-Russian Institute, and the Hollywood Arts, Sciences and Professions Council. He was the foremost policy-making figure in the last-named organization until it dissolved in 1/56. [It was LAWSON who drafted the HASP statement announcing its dissolution.] [The last public function of the HASP of any importance was a testimonial dinner honoring LAWSON which was held at Los Angeles on 11/12/55.]
