

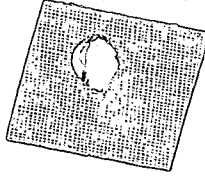

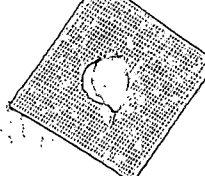

LA 3402-S reported the following information this date which informant obtained during a personal conversation today with PAULINE SCHINDLER (Bufile 100-55924). (S)(u)

SCHINDLER learned from MILTON LUBOVISKI (Bufile 100-59923) who owns and operates the Edmund's Book Store in Hollywood, (Bufile 100-197964) that JOHN HOWARD LAWSON is going to Cuba to teach. (S)(u)

Informant has no further details, but advises that informant talked to LAWSON personally just a few days ago, and LAWSON said nothing about a trip to Cuba. At that time, however LAWSON indicated to informant that he and his wife and married daughter who is visiting him, were going to spend two weeks vacationing on one of the Southern California beaches. (S)(u)
