<p>SYNOPSIS OF FACTS: JOHN HOWARD LAWSON left Los Angeles on March 31, 1950 for New York City where he will make a speaking tour in behalf of the "Hollywood 10" and remain until about June 15, 1950. In New York City he resides at 344 E. 45th Street, though his permanent address continues to be 9354 Burnet Ave., San Fernando, Calif. A confidential informant has advised of LAWSON's membership in the Communist Party. Informant advised that LAWSON was quoted "with reverence" at Hollywood Communist Party meetings. Supreme court refused to review convictions of DALTON TRUMBO and subject on Contempt of Congress charge. The court was again petitioned to hear case on basis of "an individual is not compelled to testify before a government body if he believes he will incriminate himself and laws of California where both men live permit them to refuse to state their political affiliation." LAWSON is a member of the Board of Directors of the newly formed Southern California Council of American--Soviet Friendship. The American-Russian Institute of Southern California now displays a red ceramic bust of LAWSON which is about two feet high. He wrote an article in the April 1950 issue of the "Masses &amp; Mainstream" entitled "Myth and Money". LAWSON is a delegate to the National Arts, Sciences and Professions Council Convention in New York April 28, 1950 and attended a gathering honoring Dr. HARLOW SHAPLEY, retired chairman of the National Council of Arts, Sciences and Professions.
