Subject checked into Hotel Somerset, Boston, Mass. 11/20/49 and checked out on 11/23/49. Subject addressed public meeting at Community Church, 565 Boylston St., Boston, Mass., during which he criticized all aspects of his Federal contempt trial, U. S. Foreign and Domestic Policy, U.S. leaders, and approved Russian criminal procedure. LAWSON also addressed meeting of Students Lawyers Guild of Harvard University, affiliate of National Lawyers Guild. LAWSON also met with local members of the National Council of American-Soviet Friendship.
