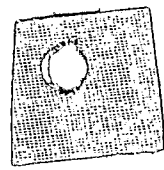
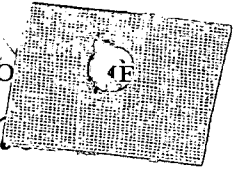

Writer states he and SUE look forward to seeing addressee "one of these days in the coming summer or fall. LAWSON indicates "We sail from Montreal on May 17th, direct to Gdynia in Poland. We stop over a few days in Warsaw, but proceed to Moscow about June 1st. We are invited there as guests of the Association of Film Makers of the USSR. I am not yet sure of further plans, except that we shall be back in Moscow for the International Film Festival in July. We are going to make an extended stay in Europe, and I am anxious to lecture and write, partly to cover expenses, but also to meet students and teachers at the universities and educational institutions, and to talk about various aspects of American theatre and film, history and culture." LAWSON does not know when "we shall be in the German Democratic Republic -- it could be in August, but it is my impression that there is not much activity at the universities (or elsewhere?) during the vacation period." The LAWSONS are going to be in Czechoslovakia in September and could go to Germany after that "if it turned out to be a more suitable time." SAC

LAWSON states "hope you and STEFAN can give me some advice, and perhaps some help, in making our journey as fruitful as possible in terms of culture contacts, meetings with people, and general service to the cause of peace." SA(C)

LAWSON indicates "We shall be in the East from May first to fifteenth: our address there: Care of PEGGY LAWSON, 115 West 16th St." SA(C)
