For the information of LA, the subject visited CP National Headquarters, 23 West 26th St., NYC, on 5/10/61, and made the comments concerning his travel plans during the visit. (S)(u)

For information of LA, the "SS Batory", GYDNIA American Line sails from Montreal, Canada, approximately the second week of each month. Subject's departure can only be verified when and if RCMP makes available to the Bureau a copy of the ship's manifest. (S)
