ReBulet to Office of Security, Department of State,
April 12, 1961, regarding foreign travel of subjects.

Security sources of this office in England, Denmark,
Norway and Sweden, have been alerted to our interest. British
Security Service, MI-5, advised on August 28 that there is no
record of subjects arriving in England. Mr. A. J. BRYHN, Nor-
wegian Security Service, advised on August 26 that there was
no record of subjects coming to Norway. Mr. E. MOGENS JENSEN,
Danish Security Service and Mr. NIELS ANDERMARK of the Swedish
Security Service, informed on August 22 and 23, respectively,
that there was no record of subjects in Denmark and Sweden. (S)

In view of previous information that subjects will
be out of the United States for a considerable period of time,
all of our sources are alerted to our interest and any informa-
tion received will be immediately furnished this office.
