HETHMON, Director, Wisconsin Center for Theater Research, Madison, Wisconsin, the name of JOHN HOWARD LAWSON, and that LAWSON had promised to cooperate with HETHMON. As CIA has requested that no dissemination of this information be made outside the Bureau, it has not been included in the details of this report. The original is filed in LA 100-7905-1177-1B35.
