NEW SUBSCRIPTION

CSSF 2357-S on APR 24 1964 furnished to SA EDWARD J. O'FLYNN the new "People's World" (PW) subscription, as reflected above. No further record of this information is being retained in the informant's file or other files of the San Francisco Office.

The PW is a West Coast communist newspaper published weekly in San Francisco.

CSSF 2357-S, who has furnished reliable information in the past, is in a position to furnish up-to-date information on the subscription list of the PW. Any disclosure of the fact that current subscription information is available to the FBI would immediately identify the informant as its source. Therefore, it is requested that current interviews and investigation of subjects be handled circumspectly in this regard.

CSSF 2357-S advised that the subscription code below the mailing address has the following significance: The date is the expiration date. A "Y" behind this date indicates a yearly subscription, and a "6" indicates a six-months' subscription. The "WE" indicates a weekend subscription, which applies in all cases now that the paper is only published weekly. A "C" designates charter subscriptions; an "LTS" designates life-time subscription and an "N" indicates a new subscriber. A "CO" means the subscription is complementary. ALL INFORMATION CONTAINED
