Since the subject is married to SARAH GIBSON (Bufile 105-112193) and has small children, and in view of his wife's unemployment, it is felt that an interview of the subject at his residence, while alone, would be almost impossible. The only other obvious approach would be to institute a surveillance of his residence and make an approach to him on the street.

This would appear impractical as the motivation behind this approach would be to solicit subject's cooperation and any information he has or may have concerning the FPCC and its activities.

Bearing in mind that the subject is an egotist and that in both of his letters concerning a desire to talk with CIA, he has mentioned that he be contacted outside the US, it is felt that an approach of subject on the streets of New York, where he is quite well known, would be useless.

In view of the above, it is NYO suggestion that a room be reserved at a major NY hotel and then subject be
