On August 10, 1962, MM 492-S, a Cuban exile residing in the Miami area who is acquainted with both pro and anti-FIDEL CASTRO activities in Cuba and the United States and who has furnished reliable information in the past, advised he has not received any information concerning subject which would indicate he was in the United States, particularly the Miami area.

MM 492-S advised he believed the subject still remains in Cuba and will remain alert for any information indicating the subject plans to leave that country.

All security responsibility in this case has been handled and the security file in the Miami Office is therefore being closed.

The Immigration and Naturalization Service (INS) lookout notice regarding subject is still in effect and this matter is being handled in Miami file 26-24802.
