(It has now been established that the Orlando BOSCH previously referred to by the Cubans and identified as Orlando BOSCH AVILA are not one and the same persons. We also cannot establish whether or not Orlando BOSCH and Orlando BOSCH MELUSA are one and the same person)

(The FABIAN previously mentioned by the Cubans and the Luis M. FABIAN PENDAS mentioned here are probably the same person and the name, DOB and photograph represent one and the same person)

(RUIZ has been identified)

(Not previously referred to by the Cubans)

(BENITEZ has been identified)

(Cannot identify OROSCO RODRIGUEZ definitly. He could also be identical to the original name referred to by the Cuban and could match the photo. Currently we have three Ramon OROSCO's listed;
