MM 867-C advised that WILLIE DARA (MM 92-1631) reportedly wants to sell his interest in the Living Room Lounge in North Miami Beach.

MM 1232-C-TE in January informed that he learned through the grapevine at Paradise Island, Bahama Islands that MIKE MC LANEY (MM 92-464) would be declared undesirable by the Bahama authorities and deported from the Islands.

Former 764-C-TE advised that MIKE MC LANEY in December, 1968, submitted a proposal and application to the Bahamian authorities for a casino gambling license. MC LANEY proposed that a gambling casino be established around Nassau in the Bahama Islands, recognizing that the Baramian Government granted an exclusive monopoly within 10 miles of New Providence Island, to the operators of the casino now operating on Paradise Island. In MC LANEY's proposal he asked the present administration to modify this agreement and proposed that Bahaminas be trained to become croupiers and dealers in the casinos to replaced the imported employees who are earning an average of \$40 to \$60 a day, including tips. Former MM 764-C-TE advised MC LANEY's proposal and application was turned down and subsequently MC LANEY was deported as undesirable with no reason furnished.
