On 4/20/63 Mr. NATHANIEL J. KLEIN of Miami Beach, Florida, and a former Bureau Agent, was in London. He informed that a friend of his, JOHN MILLS, who runs a night club and gambling room in London, had told him that subject, an American from Miami, had been in to see MILLS. KLEIN recalled that subject was a well-known gambler in Miami and had previously run a gambling establishment in Havana.

On 5/3/63 Chief Inspector JOHN PEARCE, Metropolitan Police, New Scotland Yard, advised that Alien Records reflect subject, born 2/1/45 and holding U.S. Passport 2471144, was in London in January, 1961. Records further reflect subject left London again on 4/19/63 for an unknown destination. His address in London was given as the London Hilton Hotel. Scotland Yard is extremely interested in subject in view of the possibility he might be attempting to obtain interest in legitimate gambling activities in London.

Mr. K. MURRAY, Security Officer, London Hilton Hotel, and a contact of this office, advised on 5/7/63 that Mr. and Mrs. MICHAEL McLANEY stayed at the Hilton from April 17 until April 19, 1963. Records show that subject represents "Sports Champions Inc." He listed his home address as 515 Madison Avenue, New York, and his wife's passport Number as 2230386.
