Informant states that MIKE McLANEY owes various individuals in the gambling industry throughout the United States and owes the informant himself a considerable sum of money. Informant feels that undoubtedly McLANEY will be backed financially by a group, such as the MEYER LANSKY group.

Informant states that in the next month or two his business would permit him to go to the Bahamas with his wife on a short vacation and he could contact McLANEY under a pretext of obtaining his money from McLANEY. Informant states that if the Bureau desired any information developed while in the Bahamas, he would be glad to do so.

Vegas casino figure, T. W. RICHARDSON, and SHELBY WILLIAMS, Veyaba Texas oil man, are planning to open a gambling casino next to the Caesar's Palace in June, 1967. Informant states that RICHARDSON formerly has been a "well-known drop" for money of couriers traveling in and out of Las Vegas for various gambling interests. He stated WILLIAMS used to be the silent partner of JOE LUCIA, convicted Houston gambler.
