Other than these two, Colonel SHEFFIELD EDWARDS, the former Director of Security, CIA, who presently heads the firm Sheffield Edwards Associates, 1815 H Street, N.W., Washington, D.C., is the only person who has admitted having information concerning ROSELLI's true identity in that ROSELLI stated to him that FBI Agents gave ROSELLI a photograph of himself when he was a young boy and the photograph referred to was that of PHILIP SACCO.
