

(JFK) On March 10, 1959, a confidential informant, who has furnished reliable information in the past, learned that Drew Pearson, syndicated columnist, had been in contact with Dominican Ambassador Manuel de Moya on that date. Spearson stated that he had been talking with Irving Davidson s about traveling to the Dominican Republic to see Generalissimo Rafael L. Trujillo, but added he did not want to go unless De Moya thought it was a good idea. De Moya Stated that he thought it was a wonderful idea because Pearson would be able to give a wonderful report on everything down there. Pearson informed that he planned to depart for Mexico City that date and would visit the Dominican Republic on his return to the United States. Pearson indicated that he planned to visit Port au Prince, Haiti, and would visit the Dominican Republic on about Thursday. De Moya stated he would notify the Dominican Republic athat Pearson would visit there and De Moya (S) Ireiterated that he thought Pearson's visit was an excellent idea. Pearson indicated that he knew that the Dominican Republic and Haiti were having some trouble with Cuba (not further clarified) (5 De Moyal suggested that as long as Pearson was going to visit Haiti, he should also visit the Dominican Republic

On March 4, 1959, the informant learned that I. Irving Davidson had made an appointment on that date to confer with De Moya Concerning a very important person who planned to visit the Dominican Republic and for whom the "red carpet" should be rolled out.

On March 6, 1959, informant advised that the person referred to above by Davidson was Drew Pearson
