NUMBER OF SUBJECT ORGANIZATION

On 1/22/68 TP 52-S advised that a demonstration was held on 1/20/68 by several anti-CASTRO organizations in downtown Tampa, including MIRR, which is headed in Tampa by ENRIQUE ~~SOMEILLAN~~, 2917 16th Street, Tampa. The demonstration was peaceful and about 20 people attended. Signs were carried by some of the demonstrators in support of the U. S. in Vietnam and asking the U. S. for help in fighting communism in Cuba. FIDEL CASTRO was hung in effigy.

No other activity on the part of captioned organization has been reported and according to TP 52-S there are no immediate plans for further activity.
