1. FOLL IS GIST OF LETTER FROM UNSTAR DATED 12 DEC AND

RECEIVED LATE 18 DEC:

A. (FNU) SAAVEDRA IDENTIFIED AS RAUL SAAVEDRA, HIGH OFFICIAL MINISTRY INTERIOR COMMERCE AND PROBABLY INFLUENTIAL IN PARTY, MARRIED TO CERTAIN NENITA SANCHEZ, CLOSE RELATIVE CELIA SANCHEZ MANDULEY. SAAVEDRA SPENDS MUCH TIME TRAVELLING BETWEEN HAVANA AND SANTIAGO. THIS TRAVEL APPEARS NOT PRIMARILY CONCERNED WITH HIS MINISTRY'S BUSINESS.

B. SOURCE INFO REF A IS RADIO REPAIRMAN OFTEN USED BY SAAVEDRA WHO OVERHEARD LATTER EXPRESSING CONCERN OVER FATE OF MEN IN TEXAS. UNSTAR SAYS HIS SOURCE ABSOLUTELY REFUSES GIVE NAME OF RADIOMAN AS LATTER IS AGENT OF "OTHERS". 201-289248

C. UNSTAR STATES RAYMOND B. CORTES, DALLAS CONTACT, PROBABLY ALREADY KNOWN ODENVY, DUE OTHER ACTIVITIES. UNSTAR BELIEVES HE COULD BE VALUABLE SOURCE ON OTHER MATTERS IF PROPERLY HANDLED. CORTES HAS OFFICE AT 14 AVENIDA DE LA INDEPENDENCIA, MEXICO CITY

3. NO IDENTIFIABLE WAVE TRACES NENITA SANCHEZ. SENSITIVE SOURCE INDICATES ONE RAUL SAAVEDRA VALDIVIA ARRESTED HAVA 62. NO OTHER POSS WAVE TRACES.
