 LITENSOR PERSONALLY NOT TO RELEASE DURAN UNTIL CURTIS SAID

 BUT INFORM ECHEVARRIA NEITHER CURTIS NOR PBSWING MAKING

 RELEASE MUST BE THEIRS. THIS WAS DONE AT 1200 NOON (MEXICO  
 CITY TIME) ON 28 NOVEMBER.
