As of about mid-November there was a rumor in Cuba to the effect that following the departure of the Soviets from Cuba, Fidel Castro Ruz was going to do away with the Cuban Communists and return to the platform of the 26 of July Movement.

It is also rumored that Fidel Castro is aware of the fact that to accomplish this tour de force without loss of his leading position he will have to have the full support of all elements of the 26 of July Movement.

There may be some basis for these rumors. About July 1962 a (Dr). Danilo *Mesa, a former Cuban attorney, received a letter from Jose *Duarte Lopez, the latter supposedly very close to Fide Castro, but not a Communist. The letter was allegedly written by Duarte on behalf of

Captain Perez Alamos, former Chief of the G-2 in Camaguey and one Manuel Toyos, a member of the Huber Matos group in exile approached some members of the 30 November Movement, Manolog Ray and Manuel Fernandez with the same proposal as was contained in the letter written by Duarte. It is not known whether there was any concert of action between Duarte and his group and the approach by Alamos and Toyos.

A delegate of one of the anti-Castro groups in exile telephoned his relatives in Cuba during the early part of December 1962. In talking about his brother who is a political prisoner in El Principe, this exile determined that his brother can again receive visitors and receive packages.
