1. AMBUD-7 ACTIVE MEMBER AMICE BUT NOT DIRECTLY CONTACTED BY STATION. RELATIONS WITH HIM HANDLED THROUGH AMOT-20 AND AMICE-5. CANCELLED POA BEING RENEWED.
2. A-7 AVAILABLE FOR RIO ASSIGNMENT AND PROBABLY AMENABLE, BUT RECALL IN DISCUSSION OF WAVE 3737 PROPOSAL, A-7 DESIRED KEEP FAMILY WAVE AREA AND ESTIMATED COST SEPARATE MAINTENANCE TOTAL \$300 MONTHLY PLUS OPS EXPENSES. CURRENT SALARY \$225 PER MONTH.
