THIS MATTER SUBJECT DISCUSSION AT HIGHEST LEVELS SMOOTHER GOVERNMENT INCLUDING ADMIRALTY, MINISTRY OF DEFENSE, FOREIGN OFFICE, CHIEFS OF STAFF, ETC. HAVE BEEN EXPECTING DAILY SOME FORM OF APPROVED SMOOTHER PROPOSAL FOR HIS CONSIDERATION AND WILL ADVISE WHEN SUCH RECEIVED. APPARENTLY FROM ALL INDICATIONS COME FULLY APPRECIATE OUR PROBLEMS AND ARE ATTEMPTING TO OBTAIN DECISION FAVORABLE TO OUR INTERESTS. CHIEF OF STAFF HAD VISIT AT HIGH LEVEL SMOOTHER HOSTING HIMSELF.

- A. COMMODORE ASHMORE, CEMCA (COMMUNO, BRITISH FORCES, CARIBBEAN AREA).
- B. COMMANDER [unclear], RESIDENT NAVAL OFFICER.
- C. LT. COL. PHILIPOTT, MILITARY STAFF OFFICER ON STAFF OF CEMCA.
