SUGGEST HQS CONTACT LINOZZLE AT PENTAGON FOR ASSESSMENT RELIABILITY 1959 REPORT FROM ARTURO CORONA THAT LITAMIL-9 BELIEVED TO BE COMMUNIST SINCE THIS CONFLICTS WITH NUMEROUS REPORTS RECEIVED FROM OTHER SOURCES MORE CLOSELY RELATED TO L-9 STATION. RELUCTANT CONTACT CORONA WHO NOW COMMANDING CAVALRY UNIT QUARTERMASTER. LEST THIS FLAG INTEREST IN L-9. ODISEX OFFICERS REPORT THEY HAVE LITTLE CONTACT WITH CORONA. RECEIVED ALMOST NOTHING OF REAL VALUE FROM HIM IN PAST.

2. BELIEVE ANY EFFORT LCFUTTER L-9 THIS TIME WILL RESULT IN LOSS OF AGENT WHO, WITH IMPENDING RETIREMENT LITAMIL-7, REPRESENTS ONLY PENETRATION PORUBEN EMBASSY AND WHO SHOWING INCREASING SIGNS STRAIN OF DOUBLE EXISTENCE. STATION FULLY APPRECIATES VALUE LCFUTTER PROCESS AND REVIEW OF RECORDS WILL SHOW HEAVY USE THIS INVESTIGATIVE MEASURE MEXI. L-9 HAS BEEN SUBJECT CLOSE AND CONTINUAL ASSESSMENT SINCE RECRUITMENT. PAST AND PRESENT CASE OFFICERS, WHO OFTEN DISAGREED, BOTH ASSESSED L-9 INDEPENDENTLY AS SINCERE PORUBEN PATRIOT WHO GENUINELY ANTI-AMERICAN, ANTI-COMMUNIST.
