2. LITEMPO 4 STATES THAT HIS FIRST ORAL REPORT WILL BE READY AT 1100 HRS MEXICO CITY TIME ON 29 NOVEMBER.

3. BENADUR WILL BE IN DIRECT CONTACT WITH LITEMPO 4 AT THAT TIME AND COS WILL SEND DATA AS SOON AS OBTAINED.

4. COS IS HANDLING GPFLOR CASE PERSONALLY SINCE LITENSOR, LITEMPOS AND LIENVOY INVOLVED AND NEED TO SEE LITENSOR, LIELEGANT, ECHEVARRIA AND OIL (NO ONE OF WHOM SPEAKS ENGLISH).

ALSO CONTINUOUS LIAISON WITH AMBASSADOR AND OENVOY NECESSARY AND COS WISHES CONTROL THESE PERSONALLY.
